**PLEASE READ CAREFULLY BEFORE SIGNING • All rentals are due back by 6:00 p.m.**

I accept for use **AS IS** the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this form, but not returned to the rental facility. I agree to return all rental equipment by the agreed time and date. I understand if I do not return the equipment by the agreed time and date, my signature on this form authorizes Mountain Top Sports to charge my credit card for the amount due in penalty charges. I understand there will be a late charge at 50% of my daily rental if the equipment is returned after 6:00 p.m. and before 9:00 a.m. the following day. I understand that after 9:00 a.m., I will be charged for a second day rental.

I understand that the binding system cannot guarantee the user's safety. In RECREATIONAL SNOW SPORTS such as downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release.

I understand that RECREATIONAL SNOW SPORTS such as downhill skiing involve inherent and other risks of **INJURY** and **DEATH**. I voluntarily agree to expressly assume all risks of injury or death that may result from these RECREATIONAL SNOW SPORTS, or which relate in any way to the use of this equipment.

I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slower speeds. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I **AGREE TO RELEASE AND HOLD HARMLESS** the equipment rental facility, its employees, owners, affiliates, agents, officers, directors, and the equipment manufactures and distributors and their successors in interest (collectively "PROVIDERS"), from all liability for injury, death, property loss and damage which results from the equipment user's participation in the RECREATIONAL SNOW SPORTS for which the equipment is provided, or which is related in any way to the use of this equipment, including all liability which results from the **NEGLIGENCE** of PROVIDERS, or any other person or cause.
